Terms of Reference :-

1. The Academic Committee, APMC shall empower to amend the Guidelines for conducting CME Programme and Accreditation of CME Credit Hours for modern scientific system of medicine practitioners (allopath) from time to time if it felt expedient to do so to implement in the State of Arunachal Pradesh.
2. The Academic Committee, APMC will decide on all CME proposals and matters relating thereto.
3. The Academic Committee, APMC shall look into all Academic matters.
4. Registrar cum Secretary, Arunachal Pradesh Medical Council shall assist the Academic Committee, APMC in all matters relating thereto.
5. Registrar cum Secretary, APMC will act as a convener of the meeting and convene meeting with prior approval of the Chairman of the Academic Committee, APMC whenever CME proposal received for accreditation or matter relating to academic in which Academic Committee, APMC decision will be required.
6. The Registrar cum Secretary, APMC shall present in all meeting and perform all duties as assign to him by the Academic Committee, APMC relating to the subject.


