Secretary with due permission from the Chair briefed activities taken up by APMC & appraised of action taken as –

# 1. Activities taken up by APMC:

1. The Guidelines for conducting CME Programme and accreditation of CME Credit hours framed by the Sub Committee on CME, APMC on 6<sup>th</sup> December, 2016 has been amended on 20<sup>th</sup> November, 2017 vide No.APMC-33/2016. Registrar tabled the mentioned amended Guidelines for Conducting CME Programme and Accreditation on CME before the members. He also informed that -

# 2. Appraisal of Action taken of the resolutions adopted in the 19<sup>th</sup> Council Meeting:

1. With regard to query raised during 19<sup>th</sup> Council meeting by Dr. Nabam Budh, Member, APMC pertaining to number of unregistered doctors in Govt. and private practice and it was suggested by Dr. Bombei Tayeng (Toko) to collect the data of private practitioners from the Clinical Establishment Branch of the Directorate of Health Services. Accordingly, it was requested to State Nodal Officer, Clinical Establishment and Dr. T. Lollen, SNO (CE) provided the list of three clinical establishments which are permanent registered under Clinical Establishment Act. In the said list the name of Dr. K. Nishing (allopath physician) is only found who is already registered with APMC. Secretary, APMC circulated a copy of the list as provided to all members.

The members felt that the role of Clinical Establishment needs more briefing, hence, suggested the Registrar cum Secretary, APMC to invite the SNO, Clinical Establishment in the next meeting to get clarification pertaining to function/ role of Clinical Establishment, its registration status and detail. Further, the members suggested the Registrar cum Secretary to communicate the SNO, Clinical Establishment to ensure that no Clinical Establishment be registered where doctors (allopth) practices without Arunachal Pradesh Medical Council Registration Certificate.

2. As resolved vide Agenda Item No.4, the Director Medical Education, T&R was made interim President, APMC till two more members elected as per section 2(a) of the Arunachal Pradesh Medical Council (Amendment) Act, 2017 which Council Secretariat complied. Further, as resolved, pursued with the State Govt. for completion of the election process for two more members of the Council and accordingly the election processed completed and members elected & notified in the Arunachal Pradesh Gazette vide No.APMC-13/2004, dated 24<sup>th</sup> September, 2017. Notification copy circulated to all members.

# Agenda Item-4:

# STATUS OF 5 (FIVE) UNREGISTERED DOCTORS WORKING UNDER APHS.

The President, APMC requested the Registrar cum Secretary to present the status of unregistered Govt. doctors who are yet to registered with APMC

The Registrar briefed that while processed for action by the Govt. against unregistered Govt. doctors, it was 46 defaulters working in the State Govt. as APHS officers. However, the Health & F.W department suggested to issue one more notice to them for registration before issue of Show Cause Notice. Responding to the Notice, 38 doctors got registered. Thereafter, the Health & F.W department, A.P issued show cause notices to remaining eight doctors, in the meantime, three doctors get registered and at present 5 (five) Govt. doctors are yet to be registered. The members of the Council had threadbare discussions on this issue of unregistered Modern Medicine Practitioners/Doctors practicing or serving in Govt. services and resolved that the Council should send the list of defaulting doctors to the Department of Health & Family Welfare for departmental action with a copy of intimation to defaulting Govt. APHS officers. Meantime, Council suggested that unofficial means at personal level also be endeavored to convince the defaulters to get themselves registered with APMC.

The members of the Council felt the need for further amendment of the Arunachal Pradesh Medical Council Rules, 2006 to incorporate certain clause. Therefore, it is also resolved that a Committee be constituted from Members of the Council with prior approval of the President, APMC to study and draft a proposal to submit to the State Govt. for further amendment of the Arunachal Pradesh Medical Council Rules, 2006 as required for more effectiveness and clarity.

# Agenda Item-5:

# (i) Enhancement of Contractual pay of Liaison Officer, APMC to Rs.35,000/- per month.

The President, APMC requested the Registrar cum Secretary, APMC to briefed the proposal to the members.

The Registrar informed that a representation received from Liaison Officer who is drawing a meagre salary and requested to enhance the salary to a pragmatic level of Rs.35000/- per month and cited in his letter that he is finding difficult to sustain his livelihood.

Secretary, APMC mentioned that the post of Computer Assistant cum Liaison Personnel was redesigned in the 13<sup>th</sup> Council meeting as the Liaison Officer. However, there is no charter of duties and qualifications criteria as defined earlier though Liaison Officer has been assigned all official works accept Accounts.

Therefore, the qualification criteria proposed for the post is graduate in any discipline and post graduate in Master of Information Technology (MIT)/ MBA/ MCA. And the charter of duties and responsibilities of Liaison Officer is proposed as:-

- Liaising with Departments, Medical Council of India, State Medical Councils, NGOs, etc. on behalf of the Registrar cum Secretary, Arunachal Pradesh Medical Council.
- He/ She shall be responsible for maintaining State Medical Register and all issues relating to the Registrations and medical practices.
- He/ She shall be responsible for maintaining files related to :-
  - Medical Ethics
  - Arunachal Pradesh Medical Council Act and Rules, amendment of Act and Rules, etc.
    - RTI

The Registrar cum Secretary, APMC further informed that the Salary of other staff of the Council are reasonable and at present all are getting 3% increment per year as resolved earlier in the Council meeting.

The members after discussion unanimously resolved that –

- (i) The Liaison Personnel post as upgraded to Liaison Officer, Arunachal Pradesh Medical Council with the proposed qualification & charter of duties. The salary in the pay slab of Rs.30,000/- to Rs.40,000/- and fixed @Rs.30000/- (Rupees thirty thousand) only per month w.e.f 1st April, 2018 and annual increment of 3% from financial year 2019-2020.
- (ii) The annual increment of Accountant cum Cashier and MTS enhanced from 3% to 5% from financial year 2018-2019.

practitioner with P.G qualification in Pathology is correct and laid the order copy before the members along with a copy of letter of Medical Council of India to Registrar of all the State Medical Councils of India in which it was communicated for wide circulation of the said order.

The President, APMC requested the Registrar cum Secretary, APMC to enlighten the house in this issue.

Dr. Mika Umpo, mentioned that the said letter along the passed order copy received by the Arunachal Pradesh Medical Council Secretariat and accordingly processed in File. However, the Registrar cum Secretary, APMC felt that before wide circulation of the said order certain clarification needed to a obtained from Medical Council of India such as this order passed is restricted to Pathology Laboratory or whether for all other clinical Laboratories where practice of other speciality like Biochemistry, Clinical Microbiology are involved are also required to be signed only by a registered medical practitioner with post graduate qualification in Pathology. Hence, Registrar sought clarification from MCI vide letter No.APMC-8/2007 (Vol-I), dated 18<sup>th</sup> January, 2018 and reply awaited and wide circulation is in pendency.

After discussion on the issue, the members resolved that after obtaining clarification from MCI, the order of the Hon'ble Supreme Court of India might be widely circulated and till such time, the wide circulation of the order `be kept in abeyance.

The members also resolved that the Registrar, APMC should communicate to the SNO, Clinical Establishment for wide circulation to all Clinical Establishments in the State in order to ensure that all Laboratory Reports be issued with signature by the registered Medical Practitioner only.
