Agenda Item No.2.

Appraisal of salient activities & action taken of the resolutions adopted in the 26th Council Meeting (5th meeting of 3rd Regular Council) held on 24th June, 2021.

Registrar cum Secretary, APMC briefed about the various activities carried out during the period and also the action taken of the resolution adopted in the 26th A.P Council meeting as -

(A) Activities:-

- (i) Order received vide No.Nil, dt. 01/07/2021 from the Chief Secretary, Govt. of A.P directed to submit the proposal for absorption/ regularization of existing contractual staff with justification so to examine the proposal by the Committee constituted by the Govt. of A.P for the purposes. Accordingly, the list forwarded to Secretary, G.A, GoAP who is a Member Secretary of the said Committee.
- (ii) Letter of Partnership (LoP) was signed with Omnicuris, Bangaluru, Karnataka in which Omnicuris agreed to make available a series of Digital CMEs comprising of engaging online videos lectures from experts and Medical Associations/ Institutes across various specialties free of cost to all doctors and medical students. And the APMC shall accredit credit point. It was done in compliance to letter received from NITI Aayog addressed to the Chief Secretary and to this Council via email.

(iii) CME Proposal received:

- From the Assistant Prof., Dept. of Anesthesiology, TRIHMS & Organising Secretary, APCON-2021 on "Critical Care, Anaesthesia and Pain Management" w.e.f 19th-20th November, 2021 at TRIHMS, Naharlagun, A.P which was approved by the Academic Committee, APMC on 28/09/2021. The approval was communicated to the Organizing Secretary and the Observer. And accordingly CME conducted successfully.
- From the Organising Secretary Association of Oncologists of North East India on the subject "Thyroid Cancer" on 11/12/2021 at Hotel Rising Sun which was approved by the Academic Committee, APMC on 29/11/2021. The approval was communicated to the Organizing Secretary and the Observer. And accordingly CME conducted successfully.
- (iv) The Govt. of A.P nominated Dr. Kesang Wangdi Thongdok as Member in place of Dr. P. Jayakumar, Ex-Dean, TRIHMS, Naharlagun, A.P for the remaining term of the 3rd regular APMC in pursuance of this Council.

(v) The reconstitution of 3rd Regular APMC was notified in the Gazette of A.P.

(vi) File under process on E-File for resubmission to Govt. for creation of posts which was kept in abeyance as per direction of the Govt. in the File due to austerity measures was in place till October, 2021.

Agenda Item No.4.

Multitasking Staff (MTS) appointment for ratification by the Council under Rule 22(3) of the Arunachal Pradesh Medical Council Rules, 2006.

Shri Kemo Tamut was appointed as contractual MTS under APMC after interview held on 28/02/2022 and he joined on 15/03/2022 as MTS was placed before the Council for ratification under Rule 22(3) of the APMC Rules, 2006.

The Council unanimously ratified the contractual appointment of MTS inrespect of Shri Kemo Tamut.

Agenda Item No.5.

Issue of non renewal of registration.

The Chairman requested the Registrar cum Secretary, APMC to brief on the issue.

With due permission from the Chairman, Registrar-cum-Secretary, APMC highlighted the names of doctors year-wise whose renewal are due w.e.f 2012 to 2021. Further, he gave year-wise non renewal list and tabled the list of doctors before the members for decision to take action –

After a long deliberation on the issue, the Council resolved as-

- (i) The Registrar-cum-Secretary, APMC shall communicate the defaulters list of Govt. doctors (allopath) to the Director of Health Services, Director of Family Welfare, Director of Medical Education, Training & Research and Director of TRIHMS respectively for communication to respective defaulting doctors (allopath) for immediately compliance of renewal of registration within a period of 3 (three) months, failing which Council shall delete the names of the defaulters from the State Register as per rules and necessary action shall be initiated against the defaulters.
- (ii) The Registrar, APMC shall also print in electronic media via Notice mentioning that those doctors whose registration validity expired and not yet renewed their registration are given 3 (three) months grace time period for renewal with requisite fee as applicable. After lapse of three months period, deletion of names from State Register will be done and legal action to be followed for practicing without renewal of registration in the state of Arunachal Pradesh which is clear violation of APMC rules.
- (iii) The list of APAR format of Govt. doctors (allopath) as received by the DHS/DME, T&R/DFW of A.P for assessment shall be forwarded to the Council establishment for verification of validity of registration which appears in the APAR format before evaluation by the authority. Further, DHS will communicate to all DMOs to ensure that all Govt. doctors (allopath) mentioned APMC registration No. and validity period correctly in the APAR format. The DMOs shall properly check the validity period, and if required, the DMO may direct doctors to submit a photocopy of registration certificate with the APAR format for easy verification of validity. No doctors APAR assessment be made by the authority if validity period expired/renewal not done.

Agenda Item -6:

Decision on conversion of APMC Website from static to dynamic webpage.

The Chairperson requested the Registrar to enlighten the house on the Agenda. In this context, Registrar cited that the APMC website is static in nature and maintain by NIC, Itanagar which was developed long back. Now, most of the State Medical Council started registration of doctors, renewal of registration, issue of NOC, CME and other services process online on their dynamic webpage in digital mode. The digital mode will ease the process. Thereafter, he placed a rough project cost of development of a dynamic website which may be estimated to an amount of Rs.7.00 lacs to 10.00 lacs in tune of dynamic webpage developed by other State Medical Councils in India. The estimated cost put forth as per the telephonic information received from the Developers while contacted by the APMC establishment to get the idea about the project cost. However, actual project cost may verify on invitation of tender for the project work at that point of time.

After deliberation and consideration of financial implications for conversion of APMC website from Static to Dynamic webpage, the Council resolved -

- (i) To pursue with the State Mission Directorate of Ayushman Bharat Digital Mission to find an avenue to get financial assistance or in kind for development of the interactive dynamic website of APMC under Ayushman Bharat Digital Mission or similar flagship programme of the Govt.
- (ii) To keep the proposal for conversion of APMC static website to dynamic website in abeyance for sometime as the financial implication for development is at higher side. Further, there might be a possibility of new development take place relating to registration process/ modalities by the Ethics & Medical Registration Board, NMC as cited by Dr. Koj Jarbo who is also the Member of NMC.
