Agenda Item No.1.**Appraisal of salient activities & action taken of the resolutions adopted in the 27th Council Meeting (6th meeting of 3rd Regular Council) held on 31st March, 2022.**

Registrar cum Secretary, APMC briefed about the various activities carried out during the period and also the action taken of the resolution adopted in the 27th A.P Council meeting as –

(A) Activities:-

- (i) Newly elected President APMC and Vice President APMC has been notified by the Govt. of A.P and is published in the Gazette of A.P (Extraordinary) vide No.164, Vol XXIX.
- (ii) Registered medical practitioners enrolled in the State Register between 01-06-2021 to 31-05-2022 notified in the A.P State Gazette (Extraordinary).
- (iii) E-File is under process regarding creation of various categories of regular posts under APMC. Principal Secretary (H&FW) has proposed discussion upon his return from the tour on the issue.
- (iv) Liaison Officer Debojit Goswami is identified as the APMC Nodal Officer for National Digital Health Mission under National Health Authority of GoI. He will approve Doctors verification under Health Professional Registry in the portal. So far (31/08/2022) 34 applications of Doctors in the Health Professional Registry portal has been examined and verified.
- (v) A case forwarded by S.P, Namsai relating to alleged medical negligence against Dr. Millo Bakhang and Nurses of District Hospital, Namsai has been registered. Case is currently being examined by Chairman, Ethics Committee, APMC. And a copy of SP's letter also forwarded to the Registrar, A.P Nursing Council as allegation made against Nurses also by the complainant which is beyond the jurisdiction of APMC.
- (vi) List of registered doctors for the 1st Qtr., 2022 & 2nd Qtr., 2022 were sent to NMC, New Delhi :-

(B) Action taken of resolution adopted in the 27th A.P Council meeting:

- (i) **As resolved vide Agenda Item No.3:** Induction of Dr. Kesang Wangdi Thongdok as the Member of the Academic Committee, APMC has been notified vide No.APMC-60/2019 (1), dt. 11/04/2022.
- (ii) **As resolved vide Agenda 5(1):** APMC Registrar communicated the names of renewal defaulters list of Govt. doctors to D.H.S, D.F.W, Director (TRIHMS) vide letter No.APMC-67/2019, dt. 21st April, 2022. 132/213 Renewal defaulters have got renewed.
- (iii) **As resolved vide Agenda 5(2):** APMC Registrar published Notice to registered medical practitioners regarding pending renewal in the local newspaper – “The Arunachal Times” published on 06/05/2022. The list also was uploaded in APMC website, the AP-IMA Facebook and APMC Facebook forum (<https://www.facebook.com/REGISTRAR2004>).
- (iv) **As resolved vide Agenda No.5(3):** Registrar cum Secretary, APMC has communicated to DHS citing the 27th Executive Council resolution and expressed readiness of APMC Establishment to verify status of APMC Registration/Renewal if there is any ambiguity in the APAR of individual doctors regarding the Registration status. So far, no communication received for verification.
- (v) **As resolved vide Agenda No.6:** The APMC Registrar wrote to Dr Nabam Peter, CEO of Ayushman Bharat Digital Mission, A.P vide No.APMC-68/2020 requesting logistic support for website development of APMC quoting earlier ‘minutes of meeting’ of all SMCs and National Health Authority (NHA) of India. The CEO-cum State Mission Director, ABDM, State Health Authority, Dept. of H&F.W, A.P acknowledged the receipt of letter and informed that IT Team will coordinate with National Health Authority. He assured to update as per the ensuing development.
- (vi) **As resolved vide Agenda No.7:** All necessary changes; viz name of President of APMC has been made in current Bank Account of APMC to ensure smooth financial transaction as per APMC Rule.
- (vii) **As per Agenda Item No.8 :** Relating to review of fee structure. The Registrar had written letters to all State Medical Councils of India to provide their fee structure as levied. And accordingly some of the Councils provided their fee structures.

Agenda Item No.2.

Review of fee structure.

It was resolved to increase new Registration fee from Rs.2000/- to Rs.3000/- and other fee to be kept as it is. The new registration fee shall be applicable from the date of Notification.

successful transaction snap shot to be submitted via email or whatsapp or hard copy for registration and other services where fee is applicable.

(ii) Non renewal of registration issue:-

- (a) It was resolved to issue show cause notice to registered medical practitioners who fails to renew their registration despite earlier issued Notice; and also directing them to renew their registration within 30 days failing which the names to be deleted and debarred to practice/hold office as physician or surgeon or any other office by whatever designation called in Govt. or any Institution maintained by local or other authority for treating the patients in modern scientific system of medicine or for administrative purposes. A copy of Show Cause Notice also to be sent to their respective controlling authority/ appointing authority, in case appointed in Govt. or private Hospital/ Institution. The renewal of registration defaulters list shall be widely circulated.
- (b) The respective head of Govt./ private medical establishments in the State to be directed to generate awareness among doctors during CME or other meeting in their respective establishment and communicate to comply with renewal of their registration timely which is mandatory provision to practice in the state as per the Arunachal Pradesh Medical Council Act and Rules.

Procurement of a vehicle for APMC


8. Any other items raise by members and approved for discussion (if any):
